## 4 SECTION 4: First aid measures:

### 4.1 Description of first aid measures:

Always ask medical advice as soon as possible should serious or continuous disturbances occur.

<b>Eye protection:</b>	keep an eye-rinse bottle within reach. Tight-fitting safety goggles. Wear a face shield and protective suit in case of exceptional processing problems.
